

**COLORADO MANAGED CARE COLLABORATIVE (CMCC)
SPONSORSHIP AGREEMENT**

This Sponsorship Agreement (“Agreement”), which is effective as of _____, 20____ (the "Effective Date"), is entered into by and between Colorado Managed Care Collaborative (“CMCC”) and _____ (“Sponsor”) (hereinafter, the “Parties”).

WHEREAS, CMCC is a 501(c)(3) nonprofit organization organized in the State of Colorado focused on advancing the development and role of the professional practices of managed care; and

WHEREAS, Sponsor would like to support CMCC in its efforts and carrying out its nonprofit mission; and

NOW, THEREFORE, in consideration of mutual promises, the Parties agree to as follows:

1. Sponsorship Package. Sponsor hereby acknowledges and agrees to support CMCC at the sponsorship category selected in Attachment A. CMCC hereby agrees to provide the benefits and services outlined in the selected sponsorship package. CMCC, in its sole discretion, reserves the right to modify the sponsorship benefits without notice to Sponsor so long as such modification does not materially change the nature of the sponsorship benefits outlined in Attachment A.

2. Payment. The amount payable (as listed in Attachment A) shall be due to CMCC within 30 days of delivery of invoice by CMCC. If payment is not received by CMCC within 30 days of delivery of invoice, CMCC reserves the right, in its sole discretion, to terminate this Agreement. In order for Bronze sponsorship to become effective, payment must be received by CMCC ____ days prior to the event that will be sponsored by Sponsor.

3. Term and Termination. This Agreement shall be entered into effect as of the Effective Date and expire one year from the Effective Date (“Term”). This Agreement may be terminated by either party by providing the other party 30 days advance written notice, unless otherwise specified herein. If CMCC terminates this Agreement, CMCC will refund to Sponsor a pro rata share of the Sponsorship Fees as of the date of termination within 30 days of the termination date.

4. Use of Name, Tagline, Logos. During the Term of this agreement, Sponsor hereby grants permission to CMCC to use, replicate and display its name, trade name, logos, taglines, and other identifying corporate information in recognition of Sponsor’s sponsorship of CMCC. Such use, replication and display may occur on CMCC’s website & social media accounts, in CMCC’s print materials, and projected at CMCC’s programs and events.

In consideration of the promises and undertakings set forth in this Agreement, receipt and sufficiency of which is hereby acknowledged, the Parties hereby execute this Agreement through their duly authorized representatives.
